

## DOWN PAYMENT SETTLEMENT (DPS) PROGRAM

### AMERICAN DREAM DOWNPAYMENT INITIATIVE (ADDI)

#### OBJECTIVE:

To enable low and moderate income households to purchase their first homes by providing loans to aid in covering the cost of down payment and/or settlement charges.



#### PROGRAM DESCRIPTION:

Deferred payment loans (maximum loan: **\$5,000**; minimum loan: **\$1,000**) to aid in covering customary settlement costs and/or up to one half of the required down payment to purchase a home in suburban New Castle County. To apply for DPS assistance, contact one of the Housing Counseling Agencies listed on the back of this brochure.

Borrower must occupy home as principal residence throughout the duration of the loan.



#### ELIGIBLE PROPERTIES:

- ◆ **Location:** Existing residential structures or new construction located in New Castle County.
- ◆ **Maximum selling price:** \$292,685 for a one-dwelling structure; set by the FHA single-family mortgage limit for 203(b) and 234(c) programs.
- ◆ **Property condition:** Property must be inspected by an ASHI or NAHI certified home inspector as a condition of sale. Certain DPS funding may require property to pass RIB (Residential International Building) Code and NCC adopted codes. ALL homes built prior to 1978 must meet HUD requirements regarding lead paint.



#### FINANCING TERMS:

- ◆ **Maximum loan amount:** \$5,000  
**Minimum loan amount:** \$1,000
- ◆ **Determination of loan amount:** Amount based on Housing Counselor's certified estimate of financing needed for down payment and/or settlement costs, accompanied by a good faith estimate.
- ◆ **Terms:** Loan is an 8-year loan, segmented into 2 periods.  
**Period 1:** The first 3 years are a deferral period, 3% simple interest is accruing, and payments are optional.  
**Period 2:** The remaining 5 years require monthly payments on the loan and accrued interest combined amortized at 3% interest.
- ◆ **Interest rate:** 3%  
The accrued Interest is forgiven if the loan is paid in full prior to the end of the 3-year deferral "Period 1".
- ◆ **Minimum cash contribution by borrower:** \$500.00
- ◆ **Resale restrictions:** Loan must be paid in full upon the sale of your property; or the transfer of ownership.

## ELIGIBLE HOUSEHOLDS:

**Income:** Total household income may not exceed 80% of median income for the NCC, DE area and is adjusted for family size as follows (per 2009 HUD Guidelines):

- 1 Person Household: \$43,600
- 2 Person Household: \$49,800
- 3 Person Household: \$56,050
- 4 Person Household: \$62,250
- 5 Person Household: \$67,250
- 6 Person Household: \$72,200
- 7 Person Household: \$77,200
- 8 Person Household: \$82,150

**First-time home buyers:** Borrower cannot have owned a principal residence for the last 3 years. If you owned a mobile home, you still qualify as a first-time homebuyer.

**Principal residence:** Borrower must occupy home as principal residence throughout the duration of the loan.

**Housing Counseling: Prior to closing on a home** – all borrowers must be certified as having completed a Homeownership Education Program with a New Castle County recognized HUD approved housing counseling agency.
